### BOOST POTATO AND LEEK SOUP

**CODE NO: 6710 / 6712**

<b>Description</b>	A white flaky powder with an aroma of potato and leek consisting of a mechanical blend of permitted food ingredients and additives, which when prepared with water according to instructions, produces a Potato and Leek Flavoured Soup.
<b>Properties</b>	When used as directed, one serve of this product provides 50% of the Recommended Daily Intake (RDI) of vitamins and minerals (except vitamin A, iron and zinc which are at 40% of the RDI) and 8 - 50% Estimated Safe and Adequate Daily Dietary Intake (ESADDI) of the vitamins and minerals that do not have a published RDI. The product contains approximately 1/3 of daily protein requirements.
